1. Welcome Matthew Dutton was appointed Chair and opened the meeting.

It was noted that a quorum was present.

2. Committee Elections

Chair, Vice Chair,Treasurer & Secretary

Matthew Dutton confirmed he wished to step down as Chair. All discussed how FOBS could function without a Chair and considered whether FOBS should de-register as a charity. The current committee agreed to continue in their roles until the

matter was resolved.

3. Treasurers Report

James Rees presented FOBS Accounts for the year ending 31

August 2022.

4. 2023 Fundraising All considered which activities over the past 12 months were

most profitable (with least expenditure) and were linked to community events to minimise time commitment, noting the small number of volunteers currently. The group thought that the Spinney Tree Dressing (March), Midsummer Festival (June), and Fireworks (November) were successful, and could be combined with fundraising activities run by the school, such Break the Rules Day, Bags for School, Christmas raffle,

Christmas Carol refreshments.

5. Future Meetings All agreed meetings should be held more regularly, and that a

further meeting be held this term to build support from parents, carer's and other interested parties with an association with the school, such as grandparents, parents or carers of

former pupils, local community members.

1. Welcome Matthew Dutton re-opened the meeting as Chair. It was noted

that a quorum was present.

2. Committee ElectionsChair, Vice Chair,Treasurer & Secretary(Update)

All noted that Samantha Bone had stepped forward for the Chair position, after the meeting had been adjourned. Sarah Morgan nominated Samantha Bone to be the new Chair and the nomination was seconded. All agreed that Samantha Bone be elected as Chair, and that Matthew Dutton step down as Chair. All thanked Matthew Dutton for his hard work and commitment.

James Rees and Sarah Morgan were nominated by Matthew Dutton to be Treasurer and Secretary (respectively), and these nominations were seconded. All agreed James Rees and Sarah Morgan be re-elected as Treasurer and as Secretary (respectively). All noted the Vice Chair position remained

vacant.

Sarah Morgan agreed to arrange for the necessary updates to be made with the Charities Commission.

3. Treasurers Report FYE 31 August 2022 (Update) James Rees presented updated FOBS Accounts for the year ending 31 August 2022 (Appended), noting a current bank balance of £2,943.81 (excluding funds raised from February Break the Rules Day).

6. Any Other Business

FOBS received a funding request from the school to agree an amount (in principle) towards transport costs for trips this academic year. All agreed that a total of £1,000 was reasonable, noting that combining classes to make sure coaches were full could allow for additional trips, and that any remaining funds could be used to cover part of the transport cost for the annual whole school pantomime excursion.

The school also asked for ideas to mark the Kings Coronation, noting the Parish Council would be unable to support (unlike for the Queen's Jubilee). All thought that it would be nice to organise a whole school event, and that this could be discussed at the next meeting.

There being no further business the Chair closed the meeting.
